*Protecting the Viability of the Small Donor in Modern Elections* Ben Miller, 2017 In 2010, the Supreme Court decided the landmark case *Citizens United v. FEC*. In its decision, the Court found limitations on corporate spending to be an unconstitutional restriction on the First Amendment's free speech protections. Following *Citizens United*, campaign finance reform efforts have found themselves in a precarious position. Although such efforts have been utilized with varying success since the 1700s, *Citizens United* appeared to roll back progress made on campaign finance reform over the last century. Within the past five years, however, new legislation has been proposed and implemented that attempts to reform the electoral process through alternative financing schemes designed to survive judicial review after *Citizens United*, including small-donor matching programs. A number of local jurisdictions have already begun using small-donor matching programs that aim to remove the influence of big money donors while amplifying the political voice of the average donor. This article examines the emergence of small-donor matching programs and argues that although they face a number of implementation hurdles, these programs are one of the few viable solutions for meaningful reform in the post-*Citizens United* era.

**Small Donors in Congressional Elections** Tyler James Culberson, 2014 Candidates raise substantial sums of money to compete in modern federal elections. Many electoral reform efforts focus on curbing the perceived undue influence of campaign donations by the wealthy. An intriguing new reform direction encourages small donor participation. To understand the potential effects of such reforms we utilize new internal Federal Elections Commission campaign finance data to examine patterns of small donor giving to candidates in the 2006 to 2010 congressional elections. We find encouraging small donors may be democratizing by expanding the scope of participation, in that the supply of small donors is unrelated to income levels. Unlike large donors who tend to give to incumbents, small donors give indiscriminately to incumbents, their challengers, and open seat candidates. However, we temper reformers' enthusiasm, finding that ideologically extreme incumbents tend to raise more money from small donors.

Thanks to the reporting requirements of online fundraising platforms first used by Democrats (ActBlue) and now Republicans (WinRed), we observe contribution-level information on the vast majority of small donations. We first show that the number of small donors (donors who do not give more than \$200 to any committee during a two-year electoral cycle) and their total contributions have been growing rapidly. Second, small donors include more women and more ethnic minorities than large donors, but their geographical distribution does not differ much. Third, using a saturated fixed effects model, we find that race closeness, candidate ideological extremeness, whether candidates and donors live in the same district or state, and whether they have the same ethnicity increase contributions, with lower effects for small donors. Finally, we show that campaign TV ads affect the number and size of contributions to congressional candidates, particularly for small donors, indicating that pull factors are relevant to explain their behavior.

The majority report believes that the only safe way to remove big money from party funding is to put a cap on donations from all sources, individuals and organisations, of £10,000 in any one year. Trade union affiliation fees could be regarded as a collection of individual donations providing the members individually opt-in to the fee. The cap would have a significant impact on the income of the major parties, and would inevitably require a compensating increase in support for parties from public funds. The public funding should depend on the number of votes secured in the previous election, at the rate of £3.00 a vote in Westminster elections and £1.50 a vote in devolved and European elections. This proposal would result in an annual support amount of some £23 million, equivalent to about 50p per elector per year. Income tax relief, similar to Gift Aid, should be available on donations of up to £1000 and on membership fees to political parties. Another main recommendation, among the 24 in the report, is that the existing limits on campaign spending in the period before an election should be cut by the order of 15 per cent. The proposals will create challenges for the Electoral Commission, and the Committee suggests the recommendations are implemented in time for the start of the next Parliament in 2015. Two members representing political parties dissented from some of the recommendations.
